


Background

What is an IATA EasyPay Number?

- 15-digit number
- Linked to a walled
- Can be a Single or Multi-Use Numbers
- Single Use Number: Valid for 30 days after it has been active. This number may only be used for a single transaction.
- Multi- use Number :Valid for 90 days after it has been active. This number may be used on all transactions during this time if funds are available.
- This number is entered in the GDS at the time of ticket issuance

E-Ticket Issuance

Tickets issued using IEP can be refunded, voided and exchanged like any other ticket



Refund process

- A refund can be done either via the GDS or via BSP Link. Airlines decide which options would be available to agents.
- •
- A GDS refund is done via the GDS and will be automatically processed and refunded to the agent's IATA EasyPay account within following business day.
- A BSPLink refund will require the approval of the airline, and the amount will be refunded within following day after airline's approval.
- •
- Funds are returned to the original form of payment, so if an EP ticket is refunded, the money will be returned to the agency's EP account.



Void/Cancellation of ticket:

- If cancelling/voiding the ticket on the same day, the GDS may send a reversal of the authorization and unblock the amount in real time.
- In case the GDS does not send any reversal information, the amount will be unblocked after 3 business days and made available on the agency's EP account.



Lessons learned

- It is very important that the user that creates the Easy Pay account would be an administrator and an authorized signatory as well
- Make sure that the funding account would in the name of the agency and not in the name of one of the owners
- It is highly recommended that the agent opens their EP account before they start the change from GoStandard to GoLite
- □ Make sure the data entered are accurate and documents are issued recently



Commissions

- Any potential commission your Agency is earning from credit card and EasyPay sales is paid back to the agency's bank account as per the ordinary billing calendar.
- If your Agency is GoStandard, the commissions are netted with your BSP Cash sales on the billing.
- If your Agency is GoLite, the commissions are paid via bank transfer. Your Agency must ensure that a bank account is registered with IATA if this has not already been done.
- Please note that registering a bank account when opening an EasyPay account is a separate process with a third party vendor.



BSP Kuwait

- In 2019 a similar situation happened in BSP Kuwait. Whereby the Insurance Provider stopped providing coverage to the Agencies. This resulted to 1/3 of the agencies (approximately 100 agencies) converting from GoStandard to GoLite.
- Once Airlines in BSP Kuwait could see there was a demand to use EasyPay, the majority of the Airlines ensured readiness within a 1-2 month period.
- BSP Kuwait is today the highest user of EasyPay as the Agencies are very content with the system and it has helped them to reduce costs and financial burden.
